**ELIGIBILITY:** Associate members whose dues are current are invited to submit one artwork on the dates indicated. You may become an associate member (\$45 annual dues) on day of delivery.

**ARTWORK:** All media accepted. All work must be "exhibition ready" to install with the appropriate hardware (no saw tooth hangers or clips). No dark colored mats. Work that does not adhere to the guidelines will not be exhibited. Entries must be recent original work (completed in the last 2 years) and not exhibited previously in an ALRI exhibit. Size: no larger than 48" in any direction. Sculpture not to exceed 100lbs.

**PUBLICITY:** Please submit a jpeg of the work to be exhibited. Images should be in jpeg format at 300 dpi and no larger than 6" in either direction. **Email to J. Breslin [jvbreslin@cox.net](mailto:jvbreslin@cox.net)**  
Upon delivery, please provide a typed 1-page bio/resume in clear page protector for resume notebook.

**FEE:** A \$15 hanging fee will be payable to the ALRI upon delivery of artwork on receiving days. Fill out form included with this announcement and attach to back of artwork.

**SALES & COMMISSION:** All work must be for sale. (NO POR-price on request). Prices provided by the artist should reflect the 25% commission taken by ALRI on all artwork sold.

**LIABILITY:** Although the utmost care will be taken during the installation and the duration of the exhibit, we advise that artists carry their own insurance. Neither ALRI and its representatives nor IMAGO Gallery will be held responsible for any damages or theft of artwork while on the premises and/or during the length of the exhibit.
