ELIGIBILITY: Associate members in good standing and current in their dues are invited to participate by submitting one piece of artwork. Associate Members must pay their annual dues upon delivery of work.

SELECTION ASSISTANCE: Printmaker, Carol FitzSimonds will be available to review work and assist artists in the selection of their work for this exhibit. Artists may bring in up to 3 pieces of art.

WORK: All media accepted. Size limitation: no larger than 48" in any direction. All work must be ready to install with the appropriate hardware. (no saw tooth hangers or clips). White, off-white, neutral mats. No dark colored mats. Work that does not adhere to these guidelines will not be exhibited. Entries must be recent original works (completed within the last 2 years).

FEE: \$15 hanging fee. Entrants must be an associate member of ALRI or may request membership (\$45 annual) at the time of delivery.

PUBLICITY: Artists are requested to submit an image in JPEG format of the selected piece for publicity purposes. Three dimensional artists may submit one detail in addition. **Please email all images to ALRInews@cox.net.** Images should be oriented correctly. All images must be labeled with the artist's full name, title of work and medium. Images should be 300dpi and no larger than 6" in any dimension. By entering your work, you agree to the use of your name, likeness, certain personal information and artwork in exhibition PR material.

SALES & COMMISSION: Artists are encouraged to submit works for sale. Prices provided by the Artist should reflect the 25% commission taken by ALRI on all sales. Price work accordingly. No POR listings please.

LIABILITY:

We suggest that artists carry their own insurance. Artwork is not insured by the Imago Gallery or by ALRI. All reasonable care will be taken with original art, however, neither the Imago Gallery or the Art League of Rhode Island will be responsible for loss or damage.
