Sept. 3, 11am to 1pm, Tues., Sept. 8, 1pm to 3pm and Wed., Sept. 9, 3pm to 6pm.

**EXHIBITION DATES.** September 23<sup>rd</sup> through October 16, 2009

**OPENING RECEPTION.** Friday, September 25<sup>th</sup>, 2009. 7-9 pm.

**GUEST SPEAKER:** Hope Alswang, director of RISD Art Museum will speak on  
September 26<sup>th</sup> at 2pm.

**ARTIST PANEL:** A panel of exhibiting artists will talk on October 10<sup>th</sup> at 2pm

All talks will be held at the Attleboro Arts Museum.

**REMOVAL OF WORK.** Saturday, October 17<sup>th</sup>, 12-4 pm.

**SALES.** Artists are encouraged to submit works for sale. Prices provided by the Artist should reflect the 30% and 10% commission charged respectively by the Attleboro Arts Museum and ALRI on the sale price of works sold during the exhibit. No POR listings please.

**LIABILITY.** There is a \$500.00 deductible on a per occurrence basis that will not be assumed by the museum for the price on loan. The maximum insurance value that will be covered is \$2000. If the lender chooses to maintain his or her own insurance, the Attleboro Arts Museum must be supplied with a certificate of insurance naming the Museum as an additional assured or waiving subrogation against the Attleboro Arts Museum. If the lender shall fail to supply the Attleboro Arts Museum with such a certificate, this loan agreement shall constitute a release of the Museum from any liability in connection with the artwork on loan.

**SUBMISSION GUIDELINES.** Original work must be framed, wired and ready to hang. Unstable or improperly framed work will not be accepted. No clips or saw tooth edges. Any installation works will need to be installed by the artist. There are a number of display stands available for work in 3D. **PICKUP: October 17<sup>th</sup>** The Attleboro Arts Museum has no storage capability and will not be responsible for works that remain at the museum after the exhibit ends. If you cannot pick up your work October 17<sup>th</sup>, it will be retrieved for a \$25.00 fee.
